CE MARKING

Within the large family of safe products there are those that have additional obligations, introduced by the laws on CE marking. We can define it as marked security, in other words communicated through the affixing of a synthetic and immediate mark.

Within the large family of safe products there are those that CANNOT be CE marked, because the laws do not allow it. These products are subject to a conformity procedure with Regulation (EU) 2023/988 which provides for the obligation to create the technical file.


